#### **Item 5: Leadership Update**

- Enrollment and Academic Update: Abel Perales stated for enrollment we are at 54 kids currently and then we do have a handful of students in queue. There are presentations scheduled throughout the rest of the month and into May with local junior high schools and just sharing information about our program and finding other organizations that are very similar and which students they serve and are also offering different programs and different options for secondary education.

#### b.) Action to adopt the Emergency Operation Plan.

Erin Alber, Board President made the motion with required wording to adopt the Emergency Operation Plan as follows:

I, Erin Albert, move that the Board of Directors of the Online School of Arizona Adopt the Pioneer Technology and Arts Academy of Arizona Emergency Operations Plan (EOP) adopted on February 27, 2024. This comprehensive plan outlines the school's preparedness, response, and recovery strategies for a wide range of potential emergencies, including natural disasters, technological hazards, biological incidents, and human-caused emergencies.

The plan has been developed in accordance with guidelines from the Arizona Department of Education and the Department of Emergency and Military Affairs and follows the recommendations of FEMA's Multi-Hazard Emergency Operations Planning for Schools. It emphasizes a coordinated and systematic approach to emergency management, prioritizing the safety and well-being of our students, staff, and the broader community.

Furthermore, this motion acknowledges the diligent efforts of the district and campus leadership teams, alongside the Phoenix Police and Fire Departments, in conducting a thorough review and walkthrough of our campus facilities. Their contributions have ensured that the EOP is both practical and tailored to our specific needs.

Therefore, by this motion, I recommend that the Board formally adopt the PTAA AZ EOP as the guiding document for emergency preparedness and response for the Online School of Arizona Learning Center located within the campus of Pioneer Technology & Arts Academy of Arizona. This adoption will also include a commitment to review and update the plan regularly to reflect new insights, changes in the operational environment, and improvements in emergency management practices.
